On May 31, 2023, Triumph Financial, Inc. (the "Company") issued a press release announcing that the board of directors of the Company declared a quarterly cash dividend on its 7.125% Series C Fixed-Rate Non-Cumulative Perpetual Preferred Stock (the "Series C Preferred Stock") of \$17.81 per share (equivalent to \$0.44525 per depositary share representing a 1/40 interest in a share of Series C Preferred Stock).
